Annual General Meeting Minutes

May 7, 2009.

- 13:10 Welcome to AGM by Tim Nowe
  - NICC has been in effect for 19 years.

  - 2009 Cruise Manual and Cruise Compilation Manual highlights.

## PAST CHANGES, effective Dec 17/08

- Section 2.1.2 Minimum tree count/plot reduced from 5 to 4 trees.
- Section 2.1.2(2) Minimum sampling intensity is 100m by 100m grid spacing for full measure plots. Replaces reference to 1 plot/ha.
- Section 2.1.2.1(4) Procedures for establishing the first plot on the cruise grid is revised to commence from the most SW point of the block.
- Section 3.5.9 Tree class will be determined by the forest cover age class in Mapview or the most recent inventory maps. No further requirement to age Interior Lodgepole Pine by boring.

## FUTURE

- Permits/Cut Blocks with 35% of the stand must be Red or Grey attacked, or greater Mountain Pine Beetle must be issued as a Cruised Based Permits.
- Mountain Pine Beetle Cruise Based policy.
- 12% Sampling Error on Count and Measure Plots

- Measure Plots to be on a minimum 250 meter grid. Or 1 Measure Plot/6.25 hectares.
- Sampling Error waived on Full Measure Plots on a 100m grid.

Question: Resweeps for BCTS, are they eligible?

Answer: BCTS may do a resweep prior to requesting rates. Majors are allowed only 1 resweep prior to logging (after permit is issued)

13:25 Future of Cruising by Keith Tudor, RPF, ATE Cruising Policy Forester, Revenue Branch, Victoria
Mountain Pine Beetle Cruised Based sales proposed Fall of 2009.

- Why?: Grade 4 controversy, must meet Softwood Lumber Agreement and addresses the need to efficiently reforest dead pine stand with a new growing crop.
- Stumpage, to be the same as a Scale based permit and would still require a full appraisal.
- Cut control to be based on Net Merchantable volume.
- Cost saving reduces need for MOF scaling for billing purposes. Scaling will still be done for due diligence. Scaling and Waste Surveys may not be required.
- Standards sampling error would be as per current cruising standards. Some lead time to be given. Nothing has been approved or confirmed as yet.

Transition Policies: Existing Cutting permits with no harvest, could be surrendered and re-issued as Cruise Based, must meet 12% Sampling Error.

If some logging has occurred on a cut block, it must remain as a scale based permit. Cut Control: would be based on the cruise net merchantable volume. Billing by FS 669, the licensee to submit a report monthly of areas felled, this would then be billed, monthly.

Question: How would the Ministry conduct Cut/Cruise Comparisons? Answer: To date the overall provincial cut/cruise ratio is 1.0 This is not deemed to be an issue.

Question: Will CGNF be used in the Interior?

Answer: Province is hesitant to implement as this may affect the Softwood Lumber Agreement and conflict with current Timber Pricing.
